A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER AND CITY CLERK TO EXECUTE AND ATTEST, RESPECTIVELY, THAT CERTAIN AGREEMENT BETWEEN THE CITY OF MIAMI GARDENS AND THE CITY OF OPA LOCKA FOR THE INSTALLATION OF BRICK PAVERS ALONG NORTHWEST 27TH AVENUE FROM NORTHWEST 135TH STREET TO NORTHWEST 215TH STREET, A COPY OF WHICH IS ATTACHED HERETO AS EXHIBIT A; PROVIDING FOR INSTRUCTIONS TO THE CITY CLERK; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Miami Gardens and the City of Opa Locka have been working together on a beautification initiative relating to 27th Avenue, and

WHEREAS, the portion of the work that is located within the City of Miami Gardens' City limits has been completed; however, the City of Opa Locka has not been able to complete the portion of the roadway that is within its City limits, and

WHEREAS, Opa Locka has paid the sum of \$115,000.00 to the City of Miami Gardens agree to complete a portion of the project located within the City of Opa Locka City limits, and

WHEREAS, the City Council of the City of Miami Gardens is amenable to completing the section of the beautification project located within the City of Opa Locka on Northwest 27th Avenue from Northwest 127th Street to Northwest 151st Street,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, as follows:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORITY: The City Manager and City Clerk are hereby authorized and directed to execute and attest, respectively, that certain Agreement between the City of Miami Gardens and the City of Opa Locka for the installation of brick pavers along Northwest 27th Avenue from Northwest 135th Street to Northwest 215th Street, a copy of which is attached hereto as **Exhibit A**.

Section 3. INSTRUCTIONS TO THE CITY CLERK: The City Clerk is hereby authorized to obtain three (3) fully executed copies of the subject Agreement, with one to be maintained by the City; with one to be delivered to the City of Opa Locka, and with one to be directed to the Office of City Attorney.

Section 4. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.

Staff Summary

The city of Miami Gardens and the city of Opa-Locka have been working cooperatively to ensure that 27 avenue, a major corridor in both cities, is beautifully landscape for our residents and commuters. The City of Miami Gardens' portion of the project is completed and the contractor is currently working to finish work in the Opa-Locka section of the road. Currently all the agreed funding from Miami-Dade County and the Florida Department of Transportation has been received by the Miami Gardens for both sections of the project. This inter-local agreement for the additional \$115,000 to be paid by the city of Opa-Locka, will allow our landscape contractor to complete the brick paver installation between NW 151- NW 127 in the city of Opa-Locka.

RECOMMENDATION: That City Council approves the agreement.

AGREEMENT

This **AGREEMENT**, made and entered into this 12th day of September, 2007, by and between the **CITY OF OPA-LOCKA, FLORIDA**, a political subdivision of the STATE OF FLORIDA, (hereinafter referred to as "COL", and the **CITY OF MIAMI GARDENS, FLORIDA**, a political subdivision of the STATE OF FLORIDA (hereinafter referred to as "CMG").

WITNESSETH

WHEREAS, the Florida Department of Transportation (FDOT) has entered into an agreement with the City of Opa-locka, Florida for providing highway beautification for a project along N.W. 27th Avenue from N.W. 135th Street to N.W. 215th Street; and

WHEREAS, the expenditure of funds is presently needed for brick pavers for completion of the N.W. 27th Avenue beautification project; and

WHEREAS, the City of Opa-locka has made requests to Miami-Dade County for additional funding which has not been approved as of this date; and

WHEREAS, the City of Opa-locka is desirous of moving forward with providing the additional dollars to the City of Miami Gardens, Florida for the expenditure of funds required for brick pavers to complete the N.W. 27th Avenue beautification project; and

WHEREAS, pursuant to Resolution No. 07-7093, the City Commission of the City of Opa-locka, Florida authorized the City Manager to expend funds in the amount of one hundred fifteen thousand dollars (\$115,000.00) payable to Miami Gardens for completion of the N.W. 27th Avenue Beautification Project.

NOW, THEREFORE, in consideration of the promises and covenants contained herein, the parties agree as follows:

1. COL shall provide the sum of one hundred fifteen thousand dollars (\$115,000.00) to City of Miami Gardens, required for brick pavers to complete the N.W. 27th Avenue Beautification Project upon approval by the CMG City Council.
2. CMG warrants that the installation of the brick pavers shall comply with Chapter 14 – 40, Part 1, Florida Administrative Code, and the Florida Department of Transportation "Design Standards" and "Plans Preparation Manual".

3. COL hereby incorporates by reference all applicable provisions of the Agreement between City of Miami Gardens and Miami-Dade County relating to the installation of brick pavers, from N.W. 127th Street to N.W. 151st Street.






