Each year, the Florida League of Cities sponsors an award program to honor the city manager of the year. As senior staff, we would like to ask the City Council for authorization to nominate Dr. Crew for this award based on his leadership, and personal commitment in forming the City of Miami Gardens' new Police Department. This was a tremendous achievement that many people, especially outside the City, thought could not be done. However, through his expertise, initiative and perseverance, the City overcame significant challenges in making the process an unqualified success.

RECOMMENDATION: That City Council authorize the nomination of the City Manager as Manager of the Year to the Florida League of Cities.
