A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A PURCHASE ORDER TO AGILE COURTS CONSTRUCTION COMPANY, INC., FOR TENNIS AND SPORTS COURT REPAIRS AND RENOVATIONS IN AN AMOUNT NOT TO EXCEED \$59,100.00; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is necessary for the City to maintain certain tennis and sports court facilities, and

WHEREAS, City staff advertised Bid #69412/09-1, and

WHEREAS, two (2) bids were received and publicly read, and

WHEREAS, Agile Courts Construction Company, Inc., was the apparent low bidder, and

WHEREAS, City staff is recommending, that the City Council authorize the City Manager to issue a purchase order to Agile Courts Construction Company, Inc., for tennis and sports court repairs and renovations,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.



A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE A PURCHASE ORDER TO AGILE COURTS CONSTRUCTION COMPANY, INC., FOR TENNIS AND SPORTS COURT REPAIRS AND RENOVATIONS IN AN AMOUNT NOT TO EXCEED \$59,100.00; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

Staff Summary

The Parks and Recreation Department will be utilizing Miami-Dade County Safe Neighborhood Parks Series 2005 grant funds to renovate four existing courts at Rolling Oaks Park. Specifically, staff is proposing (1) to upgrade the two existing basketball courts and (2) to redesign the two existing tennis courts into basketball courts, for a total of four newly renovated basketball courts. Please note that four new tennis courts will be constructed at Rolling Oaks Park in the near future. These proposed improvements are in accordance with the approved Parks Master Plan.

Miami-Dade County solicited for prequalification of bidders to provide tennis and sports court repairs and renovations for a period of two years and awarded to the most responsive responsible qualified contractors, Agile Courts Construction Company Inc. and McCourt Construction. In accordance with contract specifications, staff prepared

quotations to renovate the courts from each contractor. Agile Courts Construction Company, Inc. is the apparent low bidder.

Recommendation:

It is recommended that City Council approve the attached resolution authorizing the issuance of a purchase order for Agile Courts Construction, Inc, located in Miami, Florida (1) to furnish, install equipment, repair, and resurface the two existing basketball courts and (2) to furnish, install equipment, and renovate the two existing tennis courts in to two basketball courts in the amount of \$59,100.
