A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO AMPCO ELECTRIC, INC., FOR ELECTRICAL REPAIRS/ MAINTENANCE ON AN AS-NEEDED BASIS IN AN AMOUNT NOT TO EXCEED THE BUDGETED AMOUNT; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, it is necessary for the City to maintain certain city facilities, and

WHEREAS, City staff advertised ITB #07-08-015 on June 27, 2008, and

WHEREAS, fifteen (15) bids were received and publicly read, and

WHEREAS, Ampco Electric, Inc., was the apparent low bidder, and

WHEREAS, City staff is recommending, that the City Council authorize the City Manager to issue purchase orders to Ampco Electric, Inc., for electrical repairs/maintenance on an as-needed basis,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.



A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS TO AMPCO ELECTRIC, INC., FOR ELECTRICAL REPAIRS/ MAINTENANCE ON AN AS-NEEDED BASIS IN AN AMOUNT NOT TO EXCEED THE BUDGETED AMOUNT; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

Staff Summary

The City currently has twenty park facilities, police facility and a public works facility all of these facilities have either central air conditioning or wall units; irrigation systems and restrooms. The parks have four pools. These facilities from time to time require repairs and/or maintenance to the plumbing, HVAC, and electrical service. There may also be a need for a general contractor for minor repairs and minor enhancements.

Analysis:

The City's current contract for electrical, mechanical and plumbing contractors will expire in September. The current contract does not include general contractors.

Staff prepared specifications to establish a term contract with licensed contractors to include Electrical Contractors, Plumbing Contractors, Mechanical Contractors and General Contractors on an as needed when needed basis for an initial period of two years with option to renew annually for three one year terms. The contract is non-exclusive with four companies for electrical repairs and maintenance being recommended for award.

The solicitation ITB#07-08-015 advertised on June 27, 2008. A broadcast notice was sent to 597 vendors. Forty-seven vendors requested bid packages. The bids were opened on July 17, 2008. Fifteen bids were received and publicity read. A copy of the bid document and submittals are available at the assistant to the mayor and council's office for review. The tabulation sheet is attached as Exhibit "A".

All of the bid submittals were evaluated for compliance with the specifications, their ability to perform the work and each discipline's licenses were verified. The following companies' submittals were determined to be non-responsive for these disciplines:

Wis's Engineering LLC	No plumbing or general contractors license
Tropex Construction Services	No plumbing, electrical or mechanical license
Civilco Inc.	No plumbing, electrical or mechanical license

References were checked of the four apparent low bidders with favorable results. Funding for these repairs is available from the various Departments funds.

Recommendation:

The City Council approve the attached resolution authorizing the City Manager to issue purchase orders as needed for electrical repairs/maintenance to Ampco Electric, Inc. located in Ft. Lauderdale, Florida.
