A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, RATIFYING COUNCILMAN OLIVER GILBERT'S APPOINTMENT OF WILDMAYER J. WHEREAS, the City has established a Miami Gardens Progressive Young Adults ("MGPYA") to serve in an advisory capacity by giving advice to the City Manager and the City Council with respect to issues that affect the City of Miami Gardens' young adults, and

WHEREAS, the Mayor and each member of the City Council is to appoint two members to the MGPYA for two (2) and three (3) year terms respectively, and

WHEREAS, COUNCILMAN OLIVER GILBERT has appointed, Wildmayer J. Marcelin to the MGPYA for a term of three (3) years, and

WHEREAS, it is appropriate for the City Council to ratify COUNCILMAN OLIVER GILBERT's appointment,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. APPOINTMENT: The City Council of the City of Miami Gardens hereby ratifies COUNCILMAN OLIVER GILBERT appointment of Wildmayer J. Marcelin to the MGPYA for a term of three (3) years.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
