WHEREAS, the event will be held on April 2nd and 3rd at Miami Carol City High School and will be free of charge to the public, and

WHEREAS, the total budgeted amount of the event is Eight Thousand Dollars (\$8,000.00) which is currently earmarked in the "Park Sponsored Events" line item in the Department's operational budget for the current fiscal year, and

WHEREAS, State Representative, Oscar Braynon, has pledged a title sponsorship of Two Thousand Dollars (\$2,000.00) for hosting the event,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:
