

RESOLUTION NO. 2003- 17

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, APPROVING THE APPOINTMENT OF CYNTHIA W. CURRY AS INTERIM CITY MANAGER; AUTHORIZING THE MAYOR TO EXECUTE AN ADDENDUM TO THE CONSULTANT AGREEMENT BETWEEN THE CITY AND CWC & ASSOCIATES, INC., ATTACHED HERETO AS EXHIBIT "A"; PROVIDING INTERIM CITY MANAGER WITH THE AUTHORITY TO DO ALL THINGS NECESSARY TO MANAGE THE DAY-TO-DAY OPERATIONS OF THE CITY; PROVIDING FOR REPEALER; PROVIDING FOR EFFECTIVE DATE.

WHEREAS, under the City Charter, the Mayor has the authority to appoint a City Manager with the approval of the City Council; and

WHEREAS, the Mayor wishes to appoint Cynthia W. Curry as Interim City Manager to serve at the will of the City Council until the appointment of a permanent City Manager.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. Appointment of Interim City Manager. The City Council hereby approves the appointment of Cynthia W. Curry, as Interim City Manager.

Section 2. Authority of Mayor. The Mayor is hereby authorized to execute the addendum to the consultant agreement between the City and CWC & Associates, Inc., attached hereto as Exhibit "A", on behalf of the City.

Section 3. Authority of Interim City Manager. The Interim City Manager shall be responsible for the day-to-day operations of the City. The Interim City Manager shall also be responsible for supervising the Transitional Coordinator and Administrative Coordinator. The Interim City Manager shall have the authority to enter into contracts on behalf of the City and shall have the authority to extend and terminate contracts of independent contractors and individuals under her supervision, provided that notice is given to the City Council.

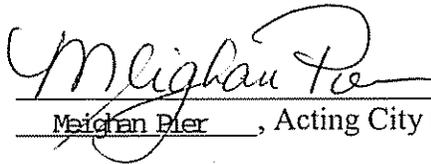

Section 5. Effective Date. This Resolution shall become effective upon adoption.

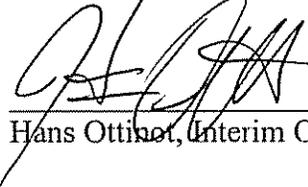
