

RESOLUTION No. 2004-101-152

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, APPROVING THE FLORIDA DEPARTMENT OF TRANSPORTATION'S PAVER PLAN; AUTHORIZING THE JOINT FUNDING OF THE PAVER PLAN; AUTHORIZING THE CITY MANAGER TO EXECUTE AN AGREEMENT WITH FLORIDA DEPARTMENT OF TRANSPORTATION IMPLEMENTING THE PAVER PLAN; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Florida Department of Transportation ("FDOT"), through its contract engineers, GBF Engineering, Inc., has prepared and transmitted a paver plan for the 183rd Street Reconstruction Project ("Paver Plan"), and

WHEREAS, the City of Miami Gardens would like to participate in the Paver Plan, and

WHEREAS, the City of Miami Gardens would like to provide funding in the amount not to exceed \$125,000.00 for the Paver Plan, and

WHEREAS, the City Council for the City of Miami Gardens would like to authorize the City Manager to budget sufficient funds in the Fiscal Year 04-05 Annual Budget for the City's participation in the Plan,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. APPROVAL: The City Council for the City of Miami Gardens hereby approves the Paver Plan for the 183rd Street Reconstruction Project as shown on FDOT Contract Plans, dated June 29, 2004, and identified as Financial Project I.D. 250200-1052-01.

Section 3. APPROPRIATION: The City Manager is hereby authorized to

appropriate funds in the amount not to exceed \$125,000.00, as the City's contribution towards the Paver Plan.

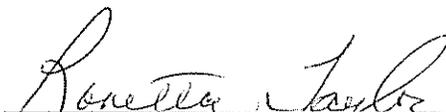
