

RESOLUTION No. 2004-104-155

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO ENTER INTO A CONTRACT WITH SALVANT & ASSOCIATES, INC., IN THE AMOUNT OF EIGHT THOUSAND EIGHT HUNDRED DOLLARS (\$8,800.00), WITH SAID AGREEMENT BEING FIRST APPROVED BY THE CITY ATTORNEY; AUTHORIZING A WAIVER OF THE COMPETITIVE BID REQUIREMENTS PURSUANT TO ARTICLE V OF ORDINANCE 2004-17, THE CITY'S PURCHASING ORDINANCE; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, City Hall is currently undergoing an expansion, and as a result, additional network service, hardware, and software programs must installed, and

WHEREAS, Salvant & Associates, Inc. installed the network, hardware and software in the existing City Hall, and

WHEREAS, the City Manager recommends that the City Council contract with Salvant & Associates, Inc., to install the additional network service, hardware, and software programs, and

WHEREAS, Salvant & Associates, Inc. has agreed to perform the necessary services in the amount of Eight Thousand Eight Hundred (\$8,800.00) Dollars, and

WHEREAS, due to the fact that Salvant and Associates, Inc. installed the network, hardware and software in the existing City Hall, and due to time constraints, the City Manager recommends that the City waive the competitive bid requirements of Article VI of the City's Purchasing Ordinance, and

WHEREAS, the City Council would like to accept the recommendation of the City Manager,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby


made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Council of the City of Miami Gardens hereby authorizes the City Manager to enter into a Contract with Salvant & Associates, Inc, for the installation and configuration of the network, hardware, and software programs in the City Hall expansion area, in the amount of Eight Thousand Eight Hundred (\$8,800.00) , with such Contract being first reviewed and approved by the City Attorney.


