

RESOLUTION No. 2004-106-157

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, PROVIDING FOR THE APPOINTMENT OF MARJORIE SPEICHER AS THE CITY'S ALTERNATE INFORMAL CITIZEN LIAISON TO CRIME WATCH OF MIAMI-DADE COUNTY, INC.; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council would like to appoint Marjorie Speicher as the alternate informal citizen liaison to Crime Watch,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.


