

RESOLUTION No. 2004-109-160

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO APPLY FOR AND ACCEPT A FEDERAL DRUG CONTROL AND SYSTEM IMPROVEMENT FORMULA GRANT, MADE AVAILABLE THROUGH THE MIAMI-DADE DEPARTMENT OF HUMAN SERVICES; AUTHORIZING THE CITY MANAGER TO EXECUTE ANY AND ALL GRANT DOCUMENTS; PROVIDING FOR A 25% MATCH OF FUNDS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Miami-Dade County ("County") has been awarded funds from the Drug Control and System Improvement Formula Grant Program ("Grant Program") under Public Law 100-690, the Federal Anti-Drug Abuse Act of 1988, and

WHEREAS, the County desires to expand the services provided by the School Resource Officer Project ("Project") by making a portion of the grant funds available to the Project, and

WHEREAS, the City Council of the City of Miami Gardens would like to participate in the Project by conducting certain classes and community events in the City, and

WHEREAS, the County, through its Human Resources Department, has made certain Grant Funds available to the City, and

WHEREAS, the maximum amount to be received from the County will be \$29,485.00 ("Grant Funds"), and

WHEREAS, for all sums received by the City, the City is required to provide a 25% match, and

WHEREAS, the City Council desires to accept the Grant Funds.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Manager is hereby authorized to apply for and accept that certain contract with the Federal Drug Control and System Improvement Formula Grant Program. The City Manager is further authorized to execute that certain contract with the Miami-Dade County Department of Human Services and any such other grant documents, as may be necessary, a copy of which is attached hereto as **Exhibit A**.

Section 3. MATCH OF FUNDS: The City Council of Miami Gardens hereby approves a match of up to 25% of the allotted Grant Award.

Section 4. INSTRUCTIONS TO THE CITY CLERK: The City Clerk is hereby authorized to obtain three (3) fully executed copies of the subject Agreement, with one to be maintained by the City; with one to be delivered to the State of Florida Department of Law Enforcement, Office of Criminal Justice Grants, and with one to be directed to the Office of City Attorney.

Section 5. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
