

RESOLUTION No. 2004-121-172

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AMENDING RESOLUTION NO. 2004-64 TO REVISE THE HOLIDAY SCHEDULE; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, previously the City Council approved Resolution No. 2004-64 establishing the official City Holidays for Calendar Year 2004, and

WHEREAS, the Staff Memorandum that accompanied Resolution No. 2004-64 requested that the City Council establish December 23, 2004 and December 24, 2004 as employee holidays; however, the adopted Resolution provides that the holidays would be December 24, 2004 and December 25, 2004, and

WHEREAS, the City Manager recommends that the City Council amend Resolution No. 2004-64 to provide that December 23, 2004 and December 24, 2004 be established as employee holidays,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.


