

RESOLUTION NO. 2004-21-72

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, APPROVING A PERMIT WITH MIAMI-DADE COUNTY DEPARTMENT OF PARK AND RECREATION TO CONDUCT PRIVATE BUSINESS ON COUNTY PROPERTY; AUTHORIZING THE MAYOR TO SIGN SAID PERMIT; PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City of Miami Gardens desires to operated a municipal park and recreation system; and

WHEREAS, the City and County are in the process of negotiating an interlocal agreement to transfer County parks to the City but such agreement is not yet complete; and

WHEREAS, in order to institute the City's programs as of February 1, 2004, it is necessary to enter into a permit to conduct private business on County property.


NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA AS FOLLOWS:

**Section 1:** Approval Permit. The City Council hereby approves the permit between the City and Miami-Dade County to Conduct Private Business On County Property , in substantially the form attached as Appendix A.

**Section 2:** Authority to Mayor. The Mayor is authorized to execute said permit.

**Section 3:** Effective Date. This Resolution shall become effective immediately upon adoption.


