

RESOLUTION NO. R2004- 38-89

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA; AUTHORIZING THE CITY MANAGER TO IMPLEMENT A "KEEP MIAMI GARDENS BEAUTIFUL PROGRAM"; AUTHORIZING THE CITY MANAGER TO TAKE ALL NECESSARY ACTIONS TO IMPLEMENT THE PROGRAM; AUTHORIZING THE MAYOR TO SIGN THE RESOLUTION; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Miami Gardens recognizes the need for, and value of, community beautification efforts; and

WHEREAS, the City of Miami Gardens has determined that beautification, litter reduction, and other community aesthetic programs have a positive visual and economic and climatic impact on a community, and when integrated in the transportation network, can also serve as a calming mechanism for traffic circulation and as a safety factor for drivers; and

WHEREAS, the City of Miami Gardens desires to undertake a formal beautification effort through the Keep America Beautiful Program; and

WHEREAS, the City of Miami Gardens finds that sufficient funds are available for the program in the City's transportation fund,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA AS FOLLOWS:

Section 1: ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2: PROGRAM AUTHORIZATION: The City Manager is hereby authorized and directed to implement a beautification program for the City of Miami Gardens under the auspices of Keep America Beautiful, Inc., as outlined in his memo of February 17, 2004, which is attached hereto as Exhibit "A," and made a part hereto of this resolution. The City Manager is further authorized to take all necessary actions to effectuate this resolution.

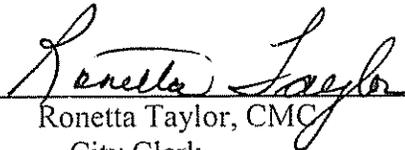
Section 3. MAYOR AUTHORIZED: The Mayor is hereby authorized to sign this resolution.
