

RESOLUTION NO 04-40-91

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE MAYOR AND CITY CLERK TO FINALIZE AN AGREEMENT FOR PROFESSIONAL SERVICES WITH CSA SOUTHEAST, INC.; PIGGYBACKING ON AN AGREEMENT BETWEEN CSA SOUTHEAST, INC AND THE CITY OF MIAMI LAKES; PROVIDING FOR INSTRUCTIONS TO CITY CLERK; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, currently many of the City's municipal services, including code enforcement, are being handled by Miami-Dade County, and

WHEREAS, the City is in the process of establishing the relevant City departments to handle certain municipal services, but establishing the necessary departments will require additional time, and

WHEREAS, code enforcement is an area of critical concern to the City, and it is in the best interest of the City to immediately contract with an entity to handle code enforcement on behalf of the City, until the City can develop a Code Enforcement Department, and

WHEREAS, the collection of occupational license taxes is also important to the enhancement of the City's revenues, and

WHEREAS, CSA Southeast Inc., is able to provide Code Enforcement administration and occupational license collection services to the City, and

WHEREAS, CSA Southeast, Inc., has contracted with the City of Miami Lakes to provide municipal services, including code enforcement, to the City of Miami Lakes, and

WHEREAS, the City Commission of the City of Miami Gardens deems it in the best interest of the City to contract with CSA Southeast, Inc., to provide municipal services to the City, by piggybacking on the Agreement between CSA Southeast, Inc. and the City of Miami Lakes,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA AS FOLLOWS:

Section 1: ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.


Section 2: AUTHORIZATION: The City Manager is hereby authorized to finalize an agreement with CSA Southeast, Inc., for the provision of municipal services. Said Agreement shall piggyback on the terms and conditions of CSA Southeast, Inc.'s Agreement with the City of Miami Lakes.

Section 3: INSTRUCTIONS TO THE CITY CLERK: The City Clerk is hereby authorized to obtain three (3) fully executed copies of the subject Agreement, with one to be maintained by the City; with one to be delivered to CSA Southeast, Inc., and with one to be directed to the Office of City Attorney.

Section 4. MAYOR AUTHORIZED: The Mayor is hereby authorized to sign this resolution.

Section 5. EFFECTIVE DATE: This Resolution shall become effective immediately upon its adoption.
