

RESOLUTION No. 2004-84-135

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO PURCHASE A SECURITY AND ACCESS CONTROL SYSTEM FROM SEGUTRONIC INTERNATIONAL INC. IN AN AMOUNT NOT TO EXCEED \$17,500; WAIVING THE COMPETITIVE BID REQUIREMENTS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, when City Hall was relocated to its new location, the City purchased the initial phase of a security and access control system ("System") from Segutronic International Inc. ("Segutronic") , and

WHEREAS, at the time the System was installed by Segutronic, it was anticipated that the City would have the ability to accommodate any anticipated expansion, and

WHEREAS, the City proposes to expand the City Hall location, and

WHEREAS, as a result of that expansion, additional equipment, wiring, installation and maintenance will be required, and

WHEREAS, the City Manager recommends that the City Council authorize the waiver of the competitive bidding procedures, and

WHEREAS, it is in the best interest of the City to waive the competitive bidding procedures due to the nature of the goods and services, and the fact that Segutronic installed the original system,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Manager is hereby authorized and directed to purchase a security and access control system, including equipment, wiring, installation and maintenance from Segutronic International Inc., in an amount not to

exceed Seventeen Thousand Five Hundred and no/100 (\$17,500) Dollars.

Section 3. WAIVER: The City Council hereby authorizes the waiver of the competitive bidding procedures of Ordinance No. 2004-17.

Section 4. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
