

RESOLUTION NO. 2004-98-149

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE AND ATTEST, RESPECTIVELY, THAT CERTAIN AGREEMENT FOR PUBLIC WORK SERVICES WITH THE FLORIDA DEPARTMENT OF CORRECTIONS FOR A TOTAL AMOUNT OF \$40,000.00 PER YEAR, A COPY OF WHICH IS ATTACHED HERETO AS EXHIBIT A; PROVIDING FOR INSTRUCTIONS TO THE CITY CLERK; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Florida Department of Corrections ("FDC") operates a program whereby minimum custody inmates provide services such as trash pick-up, landscaping, painting and other similar tasks on behalf of municipalities, and

WHEREAS, the City Manager finds it in the best interests of the City to enter into an Agreement with the FDC for the provision of certain services on behalf of the City, and

WHEREAS, pursuant to the Agreement, the City will pay the sum of Forty Thousand (\$40,000.00) Dollars to FDC, which sum is to cover the costs and salary of a correctional officer to supervise the inmates, and

WHEREAS, the City will be responsible for providing all tools, equipment, materials and protective gear necessary and appropriate to provide the work requested by the City, and

WHEREAS, the City Attorney recommends that the Agreement between FDC and the City include an indemnification provision whereby FDC will indemnify the City for the actions of the inmates.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, as follows:


Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORITY: The Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, that certain Agreement For Public Work Services With The Florida Department Of Corrections, a copy of which is attached hereto as **Exhibit A**.

Section 3. INSTRUCTIONS TO THE CITY CLERK: The City Clerk is hereby authorized to obtain three (3) fully executed copies of the subject Agreement, with one to be maintained by the City; with one to be delivered to the Florida Department of Corrections, and with one to be directed to the Office of City Attorney.

Section 4. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
