

RESOLUTION No. 2005-05-182

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDED A BID TO WEED-A-WAY, INC., FOR LOT CLEARING SERVICES, IN AN AMOUNT NOT TO EXCEED THIRTY THOUSAND (\$30,000.00) DOLLARS; AUTHORIZING THE ISSUANCE OF PURCHASE ORDERS ON AN AS-NEEDED BASIS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in October, 2004, the City took over code enforcement functions from Miami-Dade County, Florida, and

WHEREAS, in some circumstances the City is required to clear certain properties from debris and/or overgrown weeds, and

WHEREAS, City staff issued RFP No. 04-05-004 on December 1, 2004 seeking proposals for lot clearing services, and

WHEREAS, two (2) bids were received in response to the RFP, and

WHEREAS, City staff reviewed the responses and, based upon the past experiences of the firms, the responses to the RFP and cost considerations, City staff is recommending that the City utilize the services of Weed-A-Way, Inc. for lot clearing services, and

WHEREAS, City staff's recommendation is also based upon Weed-A-Way, Inc.'s past experience in providing landscaping services to the City, and

WHEREAS, City Council wishes to adopt the recommendation of City staff,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

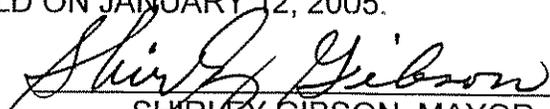
Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas

paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AWARD OF BID/AUTHORIZATION: The City Council for the City of Miami Gardens hereby awards a bid to Weed-A-Way, Inc. for lot clearing services, part and parcel to code enforcement. The City Manager is hereby authorized to use the services of Weed-A-Way, Inc. for the lot clearing services in an amount not to exceed Thirty Thousand (\$30,000.00) Dollars. In addition, the City Manager is authorized to issue purchase orders for the lot clearing services on an as-needed basis.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
