

RESOLUTION NO. 2005-06-183

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDED A BID TO, AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE WITH, AND EXECUTE AN AGREEMENT WITH, MIAMI SKYLINE CORPORATION TO CONSTRUCT A RECREATIONAL BUILDING IN SCOTT PARK, SUBJECT TO THE REVIEW AND APPROVAL OF THE AGREEMENT BY THE CITY ATTORNEY; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in November, 2004, the City issued Request for Proposal #04-05-002 ("RFP") soliciting proposals to provide construction services for a new recreational building in Scott Park, and

WHEREAS, twelve (12) bids were received in response to the RFP, and

WHEREAS, City staff reviewed the responses and, based upon the past experiences of the firms, the responses to the RFP and cost considerations, City staff is recommending that the construction services be awarded to Miami Skyline Corporation, and

WHEREAS, the City Council wishes to adopt the recommendation of the City Manager.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AWARD OF BID/AUTHORIZATION: The City Council hereby authorizes the City Manager to award the bid for the construction of the recreational center at Scott Park to Miami Skyline Corporation. The City Manager is also authorized to negotiate and enter into an agreement with Miami Skyline Corporation for the construction services at Scott Park, subject to the agreement first being reviewed and approved by the City Attorney.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
