

RESOLUTION No. 2005-101-278

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, CONFIRMING THE PURCHASE OF VEHICLES FROM SAWGRASS FORD; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, recently, the City purchased three (3) Ford Ranger Pick-up Trucks from Sawgrass Ford in the amount of \$42,893.50, and

WHEREAS, although the individual purchase of each vehicle price for the vehicles, was within the threshold authority given to the City Manager by virtue of the City's Purchasing Ordinance, because the collective purchase exceeded \$25,000.00, the purchase should have been competitively bid, and

WHEREAS, due to an oversight, the truck purchase was not competitively bid, although the Purchasing Manager contacted dealerships in the area and received the lowest quote from Sawgrass Ford,

WHEREAS, the City Council has the authority to waive the competitive bidding requirements, upon the recommendation of the City Manager that it is in the City's best interest to do so, and

WHEREAS, the vehicles will be integrated into the City's fleet and utilized by the Building Department, and

WHEREAS, funding for the purchase of the vehicles will be reimbursed through a line of credit that previously approved by the City Council,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas

paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.


