

RESOLUTION No. 2005-103-280

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING A CONCERT/FESTIVAL TO BE HELD IN THE CITY OF MIAMI GARDENS IN CONJUNCTION WITH THE 2006 FEDEX ORANGE BOWL, MORE SPECIFICALLY DESCRIBED ON EXHIBIT "A" ATTACHED HERETO; AUTHORIZING THE CITY MANAGER TO TAKE ALL NECESSARY ACTIONS FOR THE CITY TO HOST THE EVENT; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council previously adopted Resolution No. 2005-16-193, which approved the concept of an annual Fedex Orange Bowl ("Orange Bowl") event to be held in the City of Miami Gardens, and

WHEREAS, the City Council authorized Councilwoman Watson to investigate the possibility of the City hosting an event to be held in conjunction with the Orange Bowl, and

WHEREAS, Councilwoman Watson and members of City staff have met with representatives of the Orange Bowl Committee, and

WHEREAS, Councilwoman Watson and members of the City staff have prepared a proposal for approval by the City Council, for an event to be hosted by the City in conjunction with the Orange Bowl ("Proposal"), and

WHEREAS, the City Council would like to authorize the City Manager to take all actions necessary for the City of Miami Gardens to an event based upon the Proposal,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:


Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby

made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Manager is hereby authorized to take any and all steps necessary for the City of Miami Gardens to host an event in conjunction with the 2006 Fedex Orange Bowl, in accordance with the Proposal attached hereto as Exhibit "A." All approvals related to the event that would normally come before the City Council shall still be approved by the City Council.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
