

RESOLUTION No. 2005-105-282

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO REJECT ALL BIDS SUBMITTED IN RESPONSE TO RFP NO. 04-05-015, FOR THE INSTALLATION OF A FENCE WITH GATE OPERATOR AT THE PUBLIC WORKS AND MAINTENANCE; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Public Works Department and the Parks And Recreation Departments of the City of Miami Gardens are using an inspection station located at 3000 Northwest 176th Street as their main operation center, and

WHEREAS, all of the equipment that is being used by these Departments and their vehicles are being stored at this location, and

WHEREAS, the fence that surrounds the Compound is old and needs to be replaced, and

WHEREAS, City staff prepared RFP Document No. 04-05-015 on June 29, 2005 ("RFP"), and

WHEREAS, the RFP was sent to two hundred thirty (230) vendors, and

WHEREAS, four (4) vendors attended the mandatory pre-bid conference on July 11, 2005 and submitted responses, and

WHEREAS, responsive bids were evaluated for compliance with specifications, performance and cost, and

WHEREAS, all of the responsive bids exceeded the estimated budget for the project, and

WHEREAS, pursuant to the City's Purchasing Ordinance, the City Council has the right to authorize the City Manager to reject all bids and re-advertise,


NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Council for the City of Miami Gardens hereby authorizes the City Manager to reject all bids submitted in response to RFP No. 04-05-015, and to re-advertise for bids in the future.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
