

RESOLUTION NO. 2005-117-294

A RESOLUTION OF THE CITY OF MIAMI GARDENS, FLORIDA, ESTABLISHING THE TENTATIVE MILLAGE RATE FOR FISCAL YEAR 2005/2006; SETTING THE DATE, TIME AND PLACE OF PUBLIC HEARINGS TO CONSIDER THE TENTATIVE MILLAGE RATE AND TENTATIVE BUDGET AND TO ADOPT A FINAL MILLAGE AND A FINAL BUDGET; PROVIDING FOR DIRECTIONS TO THE CITY CLERK; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, only July 27, 2005, the City Council adopted Resolution No. 2005-110-287 determining the proposed Millage Rate for the fiscal year commencing October 1, 2005, and

WHEREAS, the City Manager has recommended an annual budget for Fiscal Year 2005-2006 commencing October 1, 2005, and

WHEREAS, said hearing as required by Section 200.065(2) will be held by the City Council on September 14, 2005 at 6:00 p.m., and

WHEREAS, the public and all interested parties will have the opportunity to address their comments to the City Council and the City Council will consider the comments of the public regarding the tentative millage rate,

**NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:**

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. ADOPTION OF TENTATIVE MILLAGE RATE: The City Council hereby adopts and establishes the tentative millage rate for FY 2005/2006 at 3.6384,

which is which is \$3.6384 per \$1,000.00 of assessed property within the City of Miami Gardens, Florida.

Section 3: ESTABLISHMENT OF DATE, TIME AND PLACE OF PUBLIC HEARING: The date, time and place of the first and second public hearings on the tentative millage rate, tentative budget and final millage and final budget, is set by the City Council as follows:
