

RESOLUTION No. 2005-118-295

A RESOLUTION OF THE CITY OF MIAMI GARDENS CONFIRMING COUNCILWOMAN PRITCHETT'S APPOINTMENT OF RETHA BOONE TO THE DR. MARTIN LUTHER KING, JR. HOLIDAY STEERING COMMITTEE; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on January 14, 2004, the City Council of the City of Miami Gardens adopted Resolution No. 2004-15-66, which officially recognized the third Monday of January each year as, Dr. Martin Luther King, Jr.'s birthday, and holiday celebration in the City of Miami Gardens; and

WHEREAS, pursuant to Resolution No. 2004-29-80, the City Council also established a Dr. Martin Luther King, Jr. Holiday Steering Committee ("Committee") to organize events for the holiday celebration, and

WHEREAS, the Mayor and each City Council member is permitted to nominate a member for appointment to the Committee, and

WHEREAS, previously, Councilwoman Pritchett made Sharon Frazier Stephens as her appointee to the Committee, however, Ms. Frazier Stephens is not able to continue serving on the Committee, and

WHEREAS, Councilwoman Pritchett has appointed Retha Boone to the Committee, and

WHEREAS, it is appropriate for the City Council to confirm Ms. Pritchett's appointee to the Committee,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:


