

RESOLUTION No. 2005-123-300

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDING A BID TO WORLD WASTE SERVICES, INC. FOR REFUSE COLLECTION OF LEASED CONTAINERS IN CITY PARKS, IN AN AMOUNT NOT TO EXCEED EIGHTY-ONE THOUSAND (\$81,000.00) DOLLARS AND AUTHORIZING THE ISSUANCE OF PURCHASE ORDERS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, there are refuse containers for the collection of waste and debris located in the City's parks that must be disposed of on a regular basis, and

WHEREAS, City staff investigated the prospect of contracting with a company for the leasing and disposal of the containers, and

WHEREAS, City staff prepared specifications and advertised bid document #04-05-021 on August 8, 2005 ("Bid"), and

WHEREAS, four (4) responses were received to the Bid, and

WHEREAS, the Bids were evaluated for compliance with the specifications, performance and cost, and

WHEREAS, the apparent low bidder was World Waste Services, Inc. which is located in Miami, Florida, and

WHEREAS, World Waste Services, Inc. is able to perform the services requested, and

WHEREAS, the City Manager recommends that the Bid be awarded to World Waste Services, Inc. in an amount not to exceed Eighty-One Thousand (\$81,000.00)

Dollars, and

WHEREAS, funding for this request is available in the Parks and Recreation Fiscal Year 2005-2006 Budget,



Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.


Section 2. AWARD OF BID: The City Council for the City of Miami Gardens hereby awards Bid No. 04-05-021 to World Waste Services, Inc. in an amount not to exceed Eighty-One Thousand (\$81,000.00) Dollars and authorizes the City Manager to issue purchase orders as necessary.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
