

RESOLUTION No. 2005-126-303

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, REQUESTING THAT MIAMI-DADE COUNTY RE-DESIGNATE CERTAIN PORTIONS OF THE CITY OF MIAMI GARDENS, MORE PARTICULARLY DESCRIBED ON EXHIBIT "A" ATTACHED HERETO, IN THE MIAMI-DADE COUNTY ENTERPRISE ZONE; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, previously certain parts of the City of Miami Gardens were previously designated as being within an Enterprise Zone established by Miami-Dade County, and

WHEREAS, Miami-Dade County's Enterprise expired on June 30, 2005, and

WHEREAS, the City Manager is recommending that the City request that Miami-Dade County re-designate the property shown on Exhibit "A" attached hereto, to be included in the County's new Enterprise Zone Program, and

WHEREAS, the basis for the City Manager's recommendation is that although a small percentage of the areas within the zone are now ineligible, a 20-30% poverty level still exist in the majority of the area and unemployment in and around the affected Zone still exceeds State levels then a reapportionment of the zone to include other eligible areas is warranted, and

WHEREAS, the City Council would like to accept the City Manager's recommendation and would like for Miami-Dade County to re-designate the property described on Exhibit "A" to be included in the Miami-Dade County Enterprise Zone Program,




