

RESOLUTION No. 2005-130-307

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO PURCHASE BUS BENCHES AND TRASH RECEPTACLES FROM CONTRACT CONNECTIONS, INC., IN AN AMOUNT NOT TO EXCEED \$120,000.00; AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS ON AN AS-NEEDED BASIS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on March 9, 2005, the City Council awarded a bid to Contract Connections, Inc., to provide Wabash Valley rod design benches and trash receptacles for placement at various Metro bus stops throughout the City; and

WHEREAS, the City Council authorized the City Manager to purchase the benches and receptacles in an amount not to exceed \$220,950.00; and

WHEREAS, the City Manager has determined that additional benches and receptacles are needed; and

WHEREAS, there is \$120,000.00 remaining in the fiscal year 2004-2005 budget, for the purchase of additional benches and receptacles; and

WHEREAS, the City Council would like to authorize the City Manager to purchase additional benches and receptacles; and

WHEREAS, the City will be relying upon Contract Connection's original bid pricing for this purchase.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, as follows:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby

made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Council for the City of Miami Gardens hereby authorized the City Manager to expend an amount not to exceed \$120,000.00 for the purchase Wabash Valley rod design bus benches and trash receptacles from Contract Connections, Inc., in reliance on the original bid awarded to Contract Connections, Inc. The City Manager is hereby authorized to issue purchase orders as-needed.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
