

RESOLUTION No. 2005-166-343

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO AWARD A BID TO AIR B SCHOOL BUS TRANSPORTATION IN AN AMOUNT NOT TO EXCEED ONE HUNDRED TWENTY-SIX THOUSAND DOLLARS (\$126,000) FOR TRANSPORTATION SERVICES; AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS ON AN AS-NEEDED BASIS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Miami Gardens' Parks and Recreation Department conducts after-school programs and summer holiday camp programs, and

WHEREAS, the City needs bus services in order to transport the children to the programs and various field trips during the summer and holiday camps, and

WHEREAS, City staff prepared specifications for bus transportation services and advertised the Bid Document No. 05-06-001 on October 21, 2005, and

WHEREAS, there were two (2) responsive bids, and

WHEREAS, based upon the responses, the apparent low bidder was Air B School Bus Transportation, Inc., and

WHEREAS, the City would like to use the services of Air B School Bus Transportation, Inc. to provide the transportation services, and

WHEREAS, the City Manager would like authorization to issue purchase orders pursuant to the Bid Document in an amount not to exceed One Hundred Twenty-Six Thousand (\$126,000.00) Dollars for the 2005/2006 budgeted amount,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas

paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AWARD OF BID: The City Council for the City of Miami Gardens hereby awards a bid to Air B School Bus Transportation, Inc. in accordance with Bid Document No. 05-06-001 and Air B School Bus Transportation Inc.'s response thereto.


Section 3. AUTHORIZATION OF THE CITY MANAGER: The City Manager is hereby authorized to issue purchase orders on an as-needed basis for the school bus services in an amount not to exceed the One Hundred Twenty-Six Thousand (\$126,000.00) Dollar 2005/2006 budgeted amount.

Section 4. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
