

RESOLUTION No. 2005-167-344

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY TO CONTINUE USING THE SERVICES OF HOMESTEAD CONCRETE & DRAINAGE AS PRIMARY VENDOR, AND DEVELOPMENT & COMMUNICATION GROUP OF FLORIDA, AS SECONDARY VENDOR, FOR SIDEWALK REPLACEMENT AND INSTALLATION, IN AN AMOUNT NOT TO EXCEED THE ALLOCATED BUDGETED AMOUNT, ON AN AS-NEEDED BASIS; AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS ON AN AS-NEEDED BASIS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, on July 27, 2005, the City Council of the City of Miami Gardens awarded a bid to Homestead Concrete & Drainage, located in Homestead, Florida, as the primary vendor, and Development & Communication Group of Florida, located in Miami, Florida, as the secondary vendor, on an as-needed basis, and

WHEREAS, the bids that were awarded to Homestead Concrete & Drainage and Development & Communication Group of Florida were based upon Bid Document 04-05-016 which was advertised on June 16, 2005, and

WHEREAS, Homestead Concrete & Drainage and Development & Communication Group of Florida's responses to those bids provided for pricing for a two-year period, and

WHEREAS, there is funding available in the fiscal year 2005/2006 budget for additional sidewalk replacement and installation, and

WHEREAS, the City Council would like to authorize the City Manager to issue purchase orders on an as-needed basis to Homestead Concrete & Drainage and Development & Communication Group of Florida in an amount not to exceed the

2005/2006 budgeted amount,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORIZATION OF THE CITY MANAGER: The City Manager is hereby authorized to issue purchase orders on an as-needed basis for the sidewalk replacement and installation services in an amount not to exceed the 2005/2006 budgeted amount.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
