

RESOLUTION No. 2005-27-204

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, APPROVING FINAL PLAT FOR COUNTY LINE PROPERTIES, INC. FOR PROPERTY GENERALLY LOCATED AT COUNTY LINE ROAD AND STATE ROAD 91; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, County Line Properties, Inc. has applied to Miami-Dade County for an approval of final plat for property generally located at County Line Road and State Road 91 in the City of Miami Gardens, otherwise known as Walden Commercial, and

WHEREAS, Miami-Dade County has recommended that the final plat be approved, and

WHEREAS, City staff has reviewed the application for final plat and has no objection thereto,


