

RESOLUTION No. 2005-44-221

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDING A BID AND AUTHORIZING THE PURCHASE OF ONE TWO THOUSAND (2,000) GALLON WATER TRUCK IN AN AMOUNT NOT TO EXCEED SIXTY-SIX THOUSAND FOUR HUNDRED (\$66,400.00) DOLLARS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in October, 2004 the City created the Parks Maintenance and the Public Works Departments, and

WHEREAS, to assist these Departments with their needs, the City Manager is proposing the purchase of a two thousand (2,000) gallon water truck, and

WHEREAS, City staff prepared specifications for the water truck pursuant to Invitation to Bid No. 04-05-007 ("ITB"), and

WHEREAS, there was only one responsive bid to the ITB, and

WHEREAS, the City Manager recommends that the bid be awarded to Atlantic Truck Center of Fort Lauderdale, Florida, the only responsive bidder, and

WHEREAS, partial funding for this truck shall come from the \$30,000.00 Urban and Community Forestry Grant and the remaining funding shall come from a line of credit, that was previously approved by the City Council,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

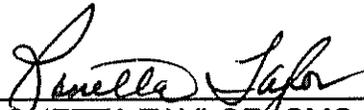
Section 2. AWARD OF BID/PURCHASE: The City Council for the City of Miami Gardens hereby awards a bid and authorizes the City Manager to purchase a two thousand (2,000) gallon water truck from Atlantic Truck Center of Fort Lauderdale, Florida, based upon ITB #04-05-007, in an amount not to exceed Sixty-Five Thousand Six Hundred (\$65,600.00) Dollars, and to purchase an extended warranty for the truck in the amount of Eight Hundred (\$800.00) Dollars for a total purchase price not to exceed Sixty-Six Thousand Four Hundred (\$66,400.00) Dollars.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
