

RESOLUTION No. 2005-47-224

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDED A BID AND AUTHORIZING THE PURCHASE OF TWO (2) FIVE CUBIC YARD DUMP TRUCKS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in October, 2004 the City created the Park Maintenance and the Public Works Departments, and

WHEREAS, to assist these Departments with their needs, the City Manager is proposing the purchase of two (2) five cubic yard dump trucks, and

WHEREAS, City staff prepared specifications for the two (2) five cubic yard dump trucks pursuant to Invitation to Bid #04-05-009 ("ITB"), and

WHEREAS, there were three (3) responsive bids to the ITB, and

WHEREAS, the City Manager recommends that the bid be awarded to Atlantic Truck Center of Fort Lauderdale, Florida, the low bidder, and

WHEREAS, funding for this truck shall come from the line of credit, that was previously approved by the City Council,

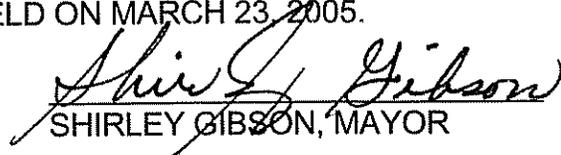
NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AWARD OF BID/PURCHASE: The City Council for the City of Miami Gardens hereby awards a bid and authorizes the City Manager to purchase two (2) five cubic yard dump trucks from Atlantic Truck Center of Fort Lauderdale, Florida, based upon ITB #04-05-009, in an amount not to exceed Fifty-Three Thousand Eight Hundred Sixty-Eight (\$53,868.00) Dollars per vehicle, for a total of One Hundred Seven Thousand Seven Hundred Thirty-Six (\$107,736.00) Dollars, and to purchase two (2) extended warranties for the dump trucks in the amount of Eight Hundred Fifty (\$850.00) Dollars each for a total purchase price not to exceed One Hundred Nine Thousand Four Hundred Thirty-Six (\$109,436.00) Dollars.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
