

RESOLUTION No. 2005-50-227

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A NON-EXCLUSIVE CONTRACT WITH KIMLEY-HORN & ASSOCIATES, INC. FOR TRAFFIC/TRANSPORTATION ENGINEERING, IN SUBSTANTIAL FORM AS THAT AGREEMENT ATTACHED HERETO AS EXHIBIT "A"; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City has several projects that require professional consultants to provide services for traffic\transportation engineering services, and

WHEREAS, the City staff prepared a Request for Proposal in accordance with the Florida Consultant Competitive Negotiation Act, and

WHEREAS, Proposal document No. 04-05-003 was advertised on November 26, 2004, and

WHEREAS, numerous proposals were received in response to the Request For Proposal, and

WHEREAS, the firm of the Kimley-Horn & Associates, Inc. ("Kimley-Horn") is capable of providing traffic\transportation engineering services to the City, and

WHEREAS, the City staff recommends that the City Council authorize an agreement with Kimley-Horn for the traffic\transportation engineering services,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.


