

RESOLUTION No. 2005-52-229

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A NON-EXCLUSIVE CONTRACT WITH CALVIN, GIORDANO & ASSOCIATES, INC. FOR PLANNING SERVICES, IN SUBSTANTIAL FORM AS THAT AGREEMENT ATTACHED HERETO AS EXHIBIT "A"; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City has several projects that require professional consultants to provide planning services; and

WHEREAS, the City staff prepared a Request For Proposal in accordance with the Florida Consultant Competitive Negotiation Act, and

WHEREAS, Proposal Document No. 04-05-003 was advertised on November 26, 2004, and

WHEREAS, numerous proposals were received in response to the Request For Proposal, and

WHEREAS, Calvin, Giordano & Associates, Inc. ("Calvin, Giordano") are capable of providing planning services to the City, and

WHEREAS, the City staff recommends that the City Council authorize an agreement with Calvin, Giordano for the planning services,




