

RESOLUTION No. 2005-53-230

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO EXECUTE A NON-EXCLUSIVE CONTRACT WITH THE FIRM OF POST, BUCKLEY, SCHUH & JERNIGAN, INC. FOR STORM WATER ENGINEERING, IN SUBSTANTIAL FORM AS THE AGREEMENT ATTACHED HERETO AS EXHIBIT "A"; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City has several projects that require professional consultants to provide services for storm water engineering; and

WHEREAS, the City staff prepared a Request For Proposal in accordance with the Florida Consultant Competitive Negotiation Act, and

WHEREAS, Proposal Document No. 04-05-003 was advertised on November 26, 2004, and

WHEREAS, numerous proposals were received in response to the Request For Proposal, and

WHEREAS, the firm of Post, Buckley, Schuh & Jernigan, Inc. ("PBS&J") is capable of providing storm water engineering services to the City, and

WHEREAS, the City staff recommends that the City Council authorize an agreement with PBS&J for the storm water engineering services,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:



Section 2. AUTHORIZATION: The City Manager is hereby authorized to execute a non-exclusive agreement with PBS&J for the provision of storm water engineering services, in substantial form as that Agreement attached hereto as Exhibit

"A".

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
