

RESOLUTION No. 2005-63-240

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, APPOINTING MEMBERS AND STAFF LIASONS TO SERVE ON THE "KEEP MIAMI GARDENS BEAUTIFUL BOARD"; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Miami Gardens has established a "Keep Miami Gardens Beautiful" (KMGB) Program to improve the aesthetics of the City, and

WHEREAS, the City Manager is recommending that the City Council appoint certain persons to serve as members of the KMGB Board, as well as staff liaisons to the KMGB Board, and

WHEREAS, the KMGB Board will serve as an advisory board to the City Council on Miami Gardens beautification efforts, and

WHEREAS, the City Council agrees with the City Manager's recommendations as they relate to the appointment of members and staff liaisons to serve on the KMGB Board,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 4. RULES AND REGULATIONS: The "Keep Miami Gardens Beautiful" Board shall be governed by Ordinance No. 2005-02-40, except that all non-staff members appointed to the Board shall be considered appointed jointly by the Mayor and the City Council and shall be subject to removal by the Mayor and the City Council, as a body. All staff liaisons shall be subject to removal and appointment by the City Manager, with confirmation by the City Council.

Section 5. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
