

RESOLUTION No. 2005-67-244

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO REJECT ALL BIDS IN RESPONSE TO REQUEST FOR PROPOSAL NO. 04-05-010, RELATING TO ENTRANCE SIGNS FOR THE CITY OF MIAMI GARDENS, PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City purchased eleven (11) pre-fabricated entrance signs to be installed at various entrances of the City, and

WHEREAS, the City's landscape architect, Keith and Schnars, prepared specifications for the installation of nine (9) of the pre-fabricated signs, and

WHEREAS, the City advertised Request For Proposal ("RFP") No. 04-05-010 on April 5, 2005, and

WHEREAS, there was only one (1) bid in response to the RFP from IGWT Construction, Inc. ("IGWT"), who submitted a bid in the amount of Seventy-Seven Thousand Nine Hundred Twenty-Eight (\$77,928.00) Dollars, and

WHEREAS, the City Manager and Public Works Director evaluated IGWT's proposal and have determined that City staff can perform the services in a timely manner and for significantly less money than the proposal submitted by IGWT,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. REJECTION OF BIDS: The City Council of the City of Miami

Gardens hereby authorizes the City Manager to reject all bids received in response to Request For Proposal No. 04-05-010.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
