

RESOLUTION No. 2005-68-245

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE CITY MANAGER TO APPLY FOR YEAR 2005 TRANSPORTATION ENHANCEMENT PROGRAM FUNDS THROUGH THE MIAMI-DADE METROPOLITAN PLANNING ORGANIZATION; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the Transportation Enhancement Program ("TEP") is an element of the Federal Highway Administration's Surface Transportation Program, which provides funding for the development of non-traditional transportation projects, and

WHEREAS, the TEP fund is distributed by the Miami-Dade Metropolitan Planning Organization, and

WHEREAS, the City of Miami Gardens operates a School Safety Enhancement Program ("Program"), and the City Manager would like to apply for funding through the TEP to assist the City with its Program, and

WHEREAS, the City Council would like to authorize the City Manager to apply for TEP funding through the Miami-Dade Metropolitan Planning Organization,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AUTHORIZATION: The City Council of the City of Miami Gardens hereby authorizes the City Manager to apply for Year 2005 funding from the Transportation Enhancement Program, as distributed by the Miami-Dade Metropolitan Planning Organization.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
