

RESOLUTION No. 2005-78-255

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, CANCELING ALL CITY COUNCIL MEETINGS IN THE MONTH OF AUGUST; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, pursuant to the City of Miami Gardens' Charter, the City Council is required to hold at least eleven (11) regular monthly meetings in each calendar year, and

WHEREAS, since the inception of the City, the City Council has held at least two (2) regular monthly meetings during every calendar month, and

WHEREAS, it is appropriate for the City Council to set aside periods during the year wherein Council meetings are suspended so as to permit City Council to have a recess period, and

WHEREAS, City Council is in agreement that the month of August would be an appropriate month to recess any and all regular City Council meetings and special City Council meetings,


NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. ESTABLISHMENT OF RECESS PERIOD: The City Council for the City of Miami Gardens hereby establishes the month of August as the City Council's annual recess period. Barring an emergency meeting called by the City Manager, there shall be no regular or special meetings held by the City Council for the City of Miami Gardens during the month of August.

Section 3. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
