

RESOLUTION No. 2005-82-259

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AUTHORIZING THE MAYOR AND CITY CLERK TO EXECUTE AND ATTEST, RESPECTIVELY, THAT CERTAIN INTERLOCAL AGREEMENT BETWEEN THE CITY OF MIAMI GARDENS AND MIAMI-DADE COUNTY FOR MONITORING COSTS AND SHARED STORM SEWER SYSTEMS, A COPY OF WHICH IS ATTACHED HERETO AS EXHIBIT A; PROVIDING FOR INSTRUCTIONS TO THE CITY CLERK; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, currently Miami-Dade County contracts with various municipalities for the performance of professional services relating to the control of pollutant discharges within municipal storm sewer systems, and

WHEREAS, the purpose of the Agreement between the County and the other co-permittees is to comply with the National Pollutant Discharge Elimination System ("NPDES"), and

WHEREAS, this is the first year that the City of Miami Gardens has been asked to participate in the program with the other municipalities, and

WHEREAS, the City Manager recommends that the City enter into an agreement with Miami-Dade County as well as the other co-permittee cities for the purpose of permitting the County to fulfill the NPDES regulations,

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, as follows:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.


Section 2. AUTHORITY: The Mayor and City Clerk are hereby authorized and directed to execute and attest, respectively, that certain Interlocal Agreement between the City of Miami Gardens and Miami-Dade County for monitoring costs and shared storm sewer systems, a

copy of which is attached hereto as **Exhibit A**.

Section 3. INSTRUCTIONS TO THE CITY CLERK: The City Clerk is hereby authorized to obtain three (3) fully executed copies of the subject Agreement, with one to be maintained by the City; with one to be delivered to Miami-Dade County, and with one to be directed to the Office of City Attorney.

Section 4. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
