

RESOLUTION No. 2006-23-369

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDING A BID IN THE AMOUNT OF \$59,800 TO PDP PRODUCTIONS, INC., FOR LIGHTING, SOUND AND STAGING SERVICES FOR THE JAZZ IN THE GARDENS FESTIVAL TO BE HELD ON MARCH 25, 2006; AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AGREEMENT(S) WITH PDP PRODUCTIONS, INC., FOR THE SERVICES; AUTHORIZING A WAIVER OF COMPETITIVE BIDDING REQUIREMENTS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City of Miami Gardens will host the "Jazz in the Gardens" event on March 25, 2006, and

WHEREAS, in order to the host the event, the City will be required to obtain the services of a vendor to provide certain lighting, sound, and staging services, and

WHEREAS, in light of the time constraints associated with obtaining the services, City staff was unable to comply with the formal bidding requirements of the City's purchasing ordinance, but instead manually contacted vendors who were capable of providing the services and requested proposals from these vendors, and

WHEREAS, the City received quotes from three vendors who are capable of providing the services, including a bid from PDP Productions, Inc. in the amount of \$59,800, Angry Production, Inc., in the amount of \$128,000.00, and Intercept Management Corp., in the amount of \$80,500.00, and

WHEREAS, PDP Productions, Inc., is able to provided the necessary services at the best cost to the City, and

WHEREAS, the City Council wished to waive the competitive bidding requirements of the City's Purchasing Ordinance for this purchase, and

WHEREAS, the City Council would like to authorize the City Manager to negotiate

and execute an agreement with PDP Productions, Inc., for the provision of lighting, sound and staging services for the Jazz in the Gardens event,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AWARD OF BID: The City Council for the City of Miami Gardens hereby awards a bid to PDP Productions, Inc. in the amount of \$59,800 for the provision of lighting, sound, and staging services for the "Jazz in the Gardens" event to be held on Saturday March 25, 2006.

Section 3. AUTHORIZATION: The City Council hereby authorized the City Manager to negotiate and execute a contract with PDP Productions, Inc., for provision of the lighting, sound, and staging services

Section 4. WAIVER OF COMPETITIVE BIDDING. The City Council hereby waives the competitive bidding requirements of the City's Purchasing Code.

Section 5. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage
