

RESOLUTION No. 2006-33-379

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDED A BID AND AUTHORIZING THE CITY MANAGER TO NEGOTIATE AND EXECUTE AN AGREEMENT WITH VILA & SON LANDSCAPING CORPORATION, FOR LANDSCAPE SERVICES FOR THE BEAUTIFICATION OF THE GOLDEN GLADES ENTRYWAY, IN THE AMOUNT OF SEVEN HUNDRED NINETEEN THOUSAND EIGHT HUNDRED FORTY-EIGHT AND 10/100 (\$719,848.10) DOLLARS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, in September of 2005, the City of Miami Gardens approved a matching grant in the amount of One Hundred Fifty Thousand (\$150,000.00) Dollars from the Miami-Dade County Landscape Committee, and

WHEREAS, specifications were prepared by the City's outside engineer, Keith and Schnars, and a Request For Proposals ("RFP") was advertised on February 3, 2006, and

WHEREAS, five (5) bids were received in response to the RFP and were opened on March 7, 2006, and

WHEREAS, the City Council authorized the low bidder, Salman Maintenance Services, Inc., to withdraw its bid, and

WHEREAS, the next lowest bidder is Vila & Son Landscaping Corporation, and

WHEREAS, Vila & Son Landscaping Corporation has agreed to provide the services in the amount of Seven Hundred Nineteen Thousand Eight Hundred Forty-Eight and 10/100 (\$719,848.10) Dollars, and

WHEREAS, the City Council would like to award the bid to Vila & Son Landscaping Corporation and would like to authorize the City Manager to negotiate and execute a contract with Vila & Son Landscaping Corporation, and

WHEREAS, in addition to the grant received from the Miami-Dade County

Landscaping Committee, funding is also available from the City's Transportation Budget,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

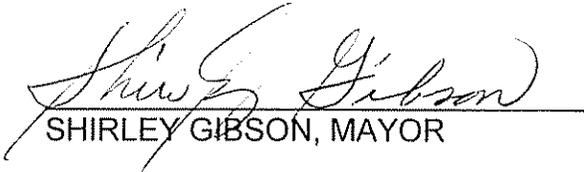
Section 2. AWARD OF BID: The City Council for the City of Miami Gardens hereby awards a bid to Vila & Son Landscaping Corporation in the amount of Seven Hundred Nineteen Thousand Eight Hundred Forty-Eight and 10/100 (\$719,848.10) Dollars for landscape beautification along the Golden Glade Entryway.

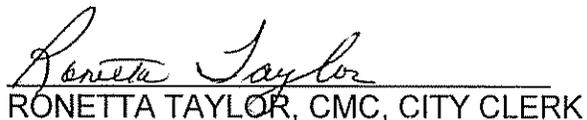
Section 3. AUTHORIZATION: The City Manager is hereby authorized to negotiate and contract with Vila & Son Landscaping Corporation for landscape beautification along the Golden Glade Entryway in accordance with this Resolution.
