

RESOLUTION No. 2006-45-391

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, APPROVING A FINAL PLAT FOR TRACTS "C," "D," "E" AND BLOCK 1 OF "PORTOFINO GARDENS", A COPY OF WHICH IS ATTACHED HERETO AS EXHIBIT "A," PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Prime Homes of Portofino Gardens ("Applicant") has applied to Miami-Dade County for the approval of a final plat for property generally located at Northwest 210 Street and Northwest 14th Place in the City of Miami Gardens, otherwise known as Tracts "C," "D," "E" and Block 1 of "Portofino Gardens", and

WHEREAS, Miami-Dade County has recommended that the Final Plat be approved, and

WHEREAS, City staff has affirmed that the Final Plat conforms to Chapter 28 of the Miami-Dade County Code in Section 177.081(1) of the Florida Statutes, and

WHEREAS, City staff further certifies that the Final Plat be in compliance with the Zoning Code and the Comprehensive Development Master Plan, and

WHEREAS, the City Council agrees to approve the Final Plat,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:


