

RESOLUTION No. 2006-61-407

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AWARDED A BID TO CARLSON FENCE COMPANY, INC., IN THE AMOUNT OF SIXTY-FOUR THOUSAND SIX HUNDRED EIGHTEEN AND NO/100 (\$64,618.00) DOLLARS, FOR THE REPAIR AND REPLACEMENT OF FENCES DAMAGED BY HURRICANE WILMA; AUTHORIZING THE CITY MANAGER TO ISSUE PURCHASE ORDERS ON AN AS-NEEDED BASIS; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, as a result of Hurricane Wilma, several of the chain link perimeter fences that surrounded the City's parks and pools were damaged, and

WHEREAS, the City prepared specifications and advertised Invitation To Bid No. 05-06-014 on May 12, 2006, and

WHEREAS, only one (1) bid was received from Carlson Fence Company, Inc., and

WHEREAS, Carlson Fence Company, Inc. was evaluated for compliance with the specifications and their ability to perform the work, and

WHEREAS, Carlson Fence Company, Inc. is qualified to perform the services and their references have been checked, and

WHEREAS, the City Manager is recommending that the City utilize the services of Carlson Fence Company, Inc. to perform the services, and

WHEREAS, funding for this expenditure is available through the reimbursement from the Federal Emergency Management Administration (FEMA),

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2. AWARD OF BID: The City Council of the City of Miami Gardens hereby awards a bid to the Carlson Fence Company, Inc., in the amount of Sixty-Four Thousand Six Hundred Eighteen (\$64,618.00) Dollars, for the repair and replacement of fencing at certain City parks and pools in accordance with their response to Invitation to Bid No. 05-06-014.

Section 3. AUTHORIZATION: The City Manager is hereby authorized to issue Purchase Orders to Carlson Fence Company, Inc. on an as-needed basis.

Section 4. EFFECTIVE DATE: This Resolution shall take effect immediately upon its final passage.
