A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, RELATING TO ELECTION; RATIFYING THE ELECTION RESULTS OF THE RUN-OFF ELECTION HELD NOVEMBER 7, 2006, FOR THE PURPOSE OF ELECTING A COUNCIL MEMBER FOR SEAT 3; DECLARING RESULTS OF SAID ELECTION; PROVIDING FOR ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE

WHEREAS, Miami-Dade County Supervisor of Elections, Lester Sola, and the Miami-Dade County Canvassing Board have examined the election results of the Run-Off Election for the City of Miami Gardens, Florida, held on November 7, 2006, as certified by the Supervisor of Elections and declares the said election results to be proper and correct and, having counted and recorded the absentee ballots in the manner provided by law; and

WHEREAS, the total votes cast in said election for each candidate is as follows:

Section 1: **ADOPTION OF REPRESENTATIONS:** The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby made a specific part of this Resolution.

Section 2: **RESULTS:** That André Williams has been elected as Residential Area Council Member for Seat 3 for an unexpired term ending September 2008.

Section 3: **EFFECTIVE DATE.** This Resolution shall become effective immediately upon adoption.


