A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, ACCEPTING THE RECOMMENDATIONS OF THE PALMETTO CORRIDOR STUDY REPORT, A COPY OF WHICH IS ATTACHED HERETO AS EXHIBIT "A"; PROVIDING FOR THE ADOPTION OF REPRESENTATIONS; PROVIDING AN EFFECTIVE DATE.

WHEREAS, Mayor Shirley Gibson participated in an annual workshop organized by Florida Public Officials Design Institute at Abacoa, in collaboration with Florida Atlantic University's Center for Environmental and Urban Solutions (CUES), and

WHEREAS, as a result of the workshop a Palmetto Corridor Study Report ("Study Report") was created, and

WHEREAS, among other things, the Study Report recommends strategies and regulatory measures to enhance the livability of the Palmetto, and

WHEREAS, the study area included the Palmetto Corridor from Golden Glades Interchange to NW 57<sup>th</sup> Avenue (Red Road); fronting commercial, industrial and residential uses; Florida Memorial University, St. Thomas University, Palmetto Lakes Industrial Park and Sunshine State Industrial Park, and

WHEREAS, the City Council would like to accept the recommendations of the Study Report,

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF MIAMI GARDENS, FLORIDA, AS FOLLOWS:

Section 1. ADOPTION OF REPRESENTATIONS: The foregoing Whereas paragraphs are hereby ratified and confirmed as being true, and the same are hereby

made a specific part of this Resolution.

Section 2. ACCEPTANCE OF PALMETTO CORRIDOR STUDY REPORT:

The City Council for the City of Miami Gardens, hereby accepts the recommendations of the Palmetto Corridor Study Report, a copy of which is attached hereto as Exhibit "A,"
