INSTRUCTIONS FOR COMPLETING RESIDENT PREFERENCE FORMS For Residents of the City of Miami Gardens

RESIDENCY QUALIFICATIONS:

In accordance with the City of Miami Gardens Ordinance No. 2010-27-235, City of Miami Gardens residents receive preference (5 points) for the purpose of employment opportunities.

TO APPLY:

1. All applicants must provide proof to verify residency: **Two documents dated more than six months ago and two documents dated less than six months ago.** Proof must show applicant's address (not P.O. Box or in care of a third party) and include the applicant's name. Same type of proof can be used as current and prior proof.

Examples of acceptable proof of residency are:

Lease or deed, or if not available, a letter from a landlord on the landlord's letterhead indicating dates of tenancy and rent payments

Student records

Florida Driver's License

Passport

Automobile registration certificate

Utility bill

Selective service card

Voter registration card

- 2. Fill out and have the Certificate of Residence and Affidavit notarized.
- 3. Minors Residing with Parents. If residing with parent, you may provide proof that shows the permanent, City of Miami Gardens address of the parent/student residence, along with the Certificate of Residence and Affidavit notarized signed by parent and notarized that states the student is now, and has been for a period of one year, living with that parent.
- 4. **Mail or deliver** the original, **NOTARIZED AFFIDAVIT** plus proof of residency as outline above and application to:
